2017-2018 STATEMENT OF FINANCIAL RESPONSIBILITY

I, the undersigned, have enrolled _____ (student's name) in grade _____ at Sacred Heart of Jesus School (hereinafter referred to as "School") for the upcoming school year.

I understand that by enrolling my child for the coming academic year, I accept the rules and regulations of School concerning payment of fees/tuition and the School's policy of restriction of access to grades and transcripts if an account has not been paid in full. Further, I promise to pay to the School the following:

For grades Pre-K through 8th, a Registration Fee of \$420 is due **January 27, 2017, for returning students.** (Late fees are assessed on registration paid after the due date as follows: January 28-\$50; February 25-\$50; March 25-\$50).

*A \$420 registration fee is due **January 11, 2017, for early admissions students.** A \$420 registration fee is due **February 17, 2017, for all other accepted new students.***

For grades K through eighth, tuition is due **June 1, 2017.** (Lump sum is prepaid by June 1 to school or through RenWeb or the Gulf Coast Bank & Trust loan is signed by June 1. A \$200 late fee is assessed on tuition paid or loans signed after the due date.

For Pre-K, tuition is paid in full by June 1, 2017, or monthly (August 2017 through May 2018) in ten equal payments. Each installment is due the first of the month and is paid to the school's business office or through RenWeb. In the event of a Pre-K student's withdrawal or dismissal, tuition owed for the month during which the student withdraws is due in full.

I acknowledge that regardless of my election to pay by Deferred Payment Plan, by lump sum, or by the month for Pre-K, my obligation to pay the amounts set forth above is unconditional, and no portion of fees, including endowment, registration, and security, will be refunded. For grades K through 8th, in the event of early withdrawal or dismissal, I agree to be responsible for the following percentage of tuition:

If I have paid more than the foregoing percentages, the school will reimburse the balance, less any outstanding fees.

I agree to pay the assigned tuition and fees as my share of the operating costs of the school. I understand that each NSF check will result in a school fee of \$25. Further, if this agreement is placed in the hands of an attorney for collection, I agree to pay reasonable attorney's fees in the amount of 25% and all cost incurred in collection.
